Statewide Survey Results



Each year we send out a Florida SHOTS statewide survey to assess what's working and what we can improve upon. This year's survey results are in, and we're happy to report that participation is at an all-time high, as we've welcomed many new providers onboard as part of the COVID-19 vaccination effort.

Here are just few of the highlights from this year's survey:

- **Expanded usage across the state: 86%** of respondents are participating or planning to participate in COVID-19 vaccine administration. Of those who answered yes to participating in COVID-19 vaccine administration, **45%** say they are newly enrolled in Florida SHOTS in order to participate in COVID-19 vaccine administration.
- **Daily entry of immunizations remains high.** **43%** percent of respondents indicated they enter immunizations daily into the registry, and among pediatric providers, that number increases to **86%**.

- **High levels of satisfaction across all program areas measured:** Percent of respondents reporting being "very satisfied" or "satisfied":

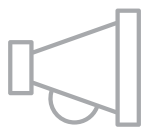

It's always nice to know what others who are enrolled in Florida SHOTS have to say about the program. In each issue, we share what some of our users think about the registry. This interview features Priscilla Fischer, Medical Assistant at Carol City Med Plus in Miami Gardens, Florida.

How have you implemented Florida SHOTS into your daily workflow?

We call our patients the day before to confirm their upcoming appointments and remind them of any vaccinations. When they come into the office on the day of their appointment, we first check the patient information and update the system with any changes like address and phone number and ensure the patient record is up to date.

What do you think is the best feature for your patients?

I think the best feature for our patients is having all the shot records in one place and being able to verify their information and keep it updated every time the patient has an appointment in our office.

What do you think is the best feature of the Florida SHOTS?

It is amazing. Florida SHOTS is a very helpful site for us since we work with pediatric patients and we can verify the patients' overdue vaccines, update their new vaccines, and print out forms for school.

If another doctor's office were to call and ask you if they should enroll in Florida SHOTS, what would you say?

I would strongly recommend they enroll because it is a good resource for every doctor's office to see where and when each patient received vaccines from another office or health department. It is the best way to get a complete vaccine history for patients of all ages.

Data Quality Spotlight

DATA UPLOAD

Can't find a vaccine record that was uploaded? We're here to help. Florida SHOTS offers tools to find errors and rejections for your data uploads. Once logged into the system, click on "**System Transactions**," then "**Transaction Statistics**." This report can show you all of the shots your organization has uploaded for a certain time period - including any errors, rejections, or warnings. Some of the most common errors we see are missing patient demographic information and incorrect vaccine expiration dates. Regularly running these reports helps providers make corrections to ensure accurate patient records.

Upload Tip:

Patient ethnicity, as well as other data elements, are reporting requirements per the Department of Health, Emergency Rule 64DER20-43.



Did You Know?

The Form DH 681, or *Religious Exemption from Immunization Form*, is only issued for Kindergarten through 12th grades if immunizations are in conflict with the religious tenets and practices of the child's parent or guardian. This exemption is ONLY issued by a County Health Department (CHD) and is not available to adults or college students.

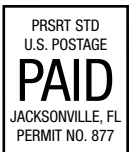
492 MILLION+ SHOTS

As of August 1, 2021, we've processed more than 492 million shots via data upload from over 14,900 participating healthcare providers and multiple insurance organizations. There are also 2,889 real-time live web service healthcare provider connections through 117 EHRs.

Something not right?

Unmonitored data can result in faulty reports.

Find errors and make corrections using tools offered by Florida SHOTS. Try this for your organization: log into the system and click on "System Transactions," then choose "Transaction Statistics." Enter a timeframe and see all the shots your organization has uploaded during those dates - including any errors, rejections, or warnings. Florida SHOTS can also use this information to create a spreadsheet called the Data Quality Report, which makes seeing any issues with reporting even easier. Using these tools may save valuable information within your patient records!
