Electronically Certified DH Form 680s



Give Parents Access to Their Child's Form

The back-to-school rush is in full swing, and your office will continue to administer vaccines and certify numerous DH Form 680s. Creating electronically certified DH Form 680s within Florida SHOTS is a huge timesaver for you and your patients. By e-certifying the DH680, you not only save a copy accessible by schools and childcare providers, but also gain the ability to allow a parent/guardian to print the DH Form 680 themselves.

To retrieve the certified DH Form 680, parents/guardians will be required to enter the Certification PIN and State Immunization ID, found on the information sheet your office will provide. This PDF version of the form allows it to be printed or saved for easy access!

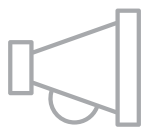

What do you think is the best feature of Florida SHOTS for your office?

The Immunization Status page with minimum/maximum dates for vaccines, really helps new staff AND old staff (like me) who do not give vaccines every day. We are a teaching facility, so Florida SHOTS is a great asset to train students at all levels.

What do you think is the best feature of Florida SHOTS for patients?

We give parents the PIN number for their 680 forms so they can print their child's up-to-date shot records for school and childcare entry.

How have you implemented Florida SHOTS into your workflow?

Our front desk clerical staff are trained to input vaccination data, print electronically certified 680 forms and 687 for parents, freeing up our clinical staff.

If another doctor's office were to call and ask you why they should enroll, what would you say?

It is super user friendly, improves workflows, and has lots of training and assistance available.

Data Quality Spotlight

DATA UPLOAD

Don't Forget to Check Your Codes!

Did you know that having incorrect or outdated CVX, MVX and VIS codes in your EHR's immunization table can result in vaccine messages getting rejected and not transferring to patient records? Make sure to regularly review and update to ensure you have the correct codes. See here for important links:

1. **CVX code table:** Immunization codes sent by your EMR to FLSHOTS.
2. **MVX code table:** Vaccine manufacturers table.
3. **Vaccine Information Statements (VIS) dates:** These are the most up-to-date CDC patient vaccine information forms.

Upload Tip:

Patient ethnicity, as well as other data elements, are reporting requirements per the Department of Health, Emergency Rule 64DER20-43.



Did You Know?

Reporting to Florida SHOTS is required for many healthcare providers. As of January 2021, the state legislature requires healthcare providers and college health centers administering vaccinations to patients from birth through age 23 to report vaccinations to Florida SHOTS, unless the parent or guardian has opted out of the registry.

Tech Tips



“Sometimes parents and guardians lose their DH680 forms. Is there a way to provide additional copies of the form without them having to come back to our office?”

Yes! Healthcare providers can generate and electronically certify DH680 forms in Florida SHOTS and attach a PIN to allow parents/guardians to access the form! The form may be printed from any computer and is legal and valid in the state of Florida for admittance to schools and daycare facilities. 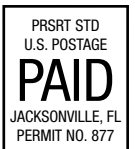
529 MILLION+ SHOTS

As of August 1, 2022, we've processed more than 529 million shots via data upload from over 15,000 participating healthcare providers and multiple insurance organizations. There are also 2,953 real-time live web service healthcare provider connections through 136 EHRs.
